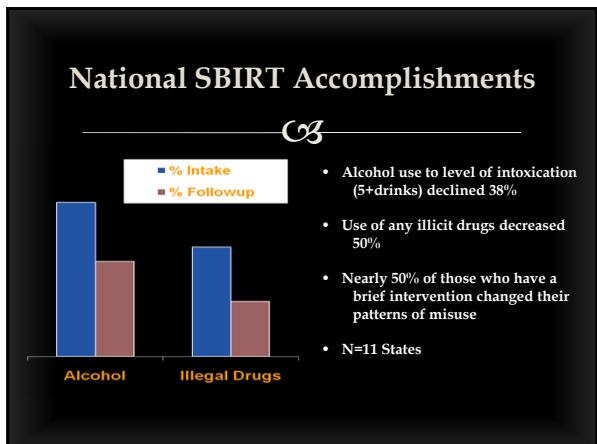

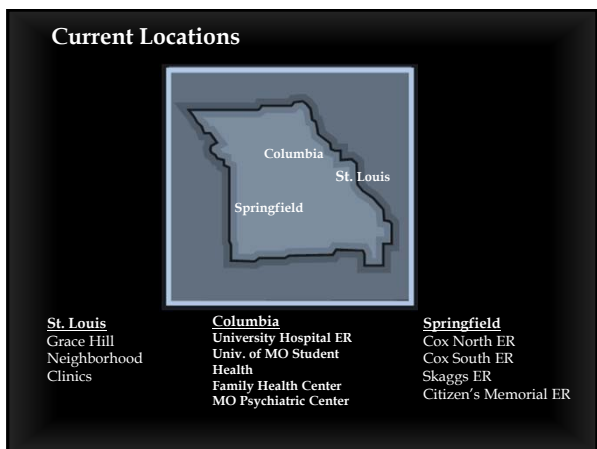

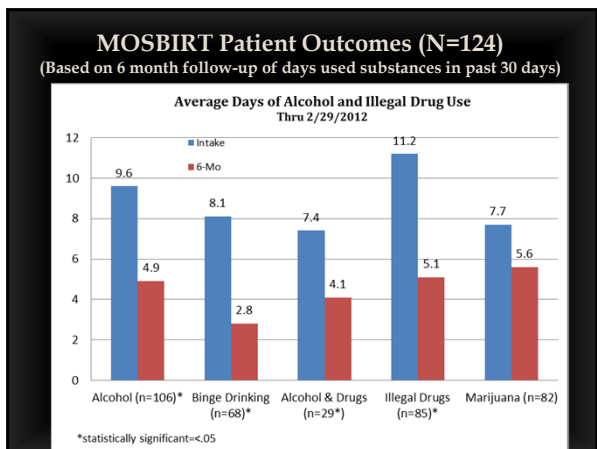

 (Based on 5 point scale 1=Strongly disagree to 5=strongly agree)

Item	Mean (SD)	% Agree or Strongly Agree
I was embarrassed when asked about my substance use.	1.98 (1.2)	11%
I think it is important for my health care provider to ask about my substance use.	4.2 (1.0)	83%
The health coach explained health behaviors in a way I could understand.	4.5 (0.7)	95%
The health coach answered my questions.	4.4 (0.8)	92%
I am overall satisfied with the health coach who served me.	4.7 (0.7)	96%
